

# WARRANTY

## 5-Year Limited Warranty

Subject to the “Exclusions” and “Limitations” set forth below, Fluidmaster Inc. promises to the consumer to repair, or at the option of Fluidmaster Inc. to replace any part of this plumbing product which proves to be defective in workmanship or materials under normal use for five years from the date of purchase. All costs of removal, transportation, and reinstallation to obtain warranty service shall be paid by the consumer. During this “Limited Five-Year Express Warranty,” Fluidmaster Inc. will provide, subject to the “Exclusions” section set forth below, all replacement parts within coverage free of charge, necessary to correct such defects. This “Limited Five-Year Warranty” is null and void if this plumbing product or workmanship, provided that such product was properly installed, used, maintained, and serviced in accordance with instructions. Fluidmaster reserves the right to make such inspections as necessary to determine cause(s) of failure or defect. Fluidmaster is not responsible for the cost of removal, return and/or reinstallation of the product, or any damages occasioned thereby. **Note:** This applies to any used product past the initial 60 days of return.

<b>Years Two (2) to Three (3) from date of purchase</b>	75% Coverage	Fluidmaster will provide discounted parts to repair or replace defective components. This may include replacement of the unit at discretion of Fluidmaster. List of parts available on website. Shipping included.
<b>Years Four (4) to Five (5) from date of purchase</b>	50% coverage	Fluidmaster will provide discounted parts to repair or replace defective components. Parts beyond supported list will be available for purchase. List of parts available on website. Shipping included.

Replacement products and parts are warranted for the remaining portion of the original warranty period or ninety (90) days, whichever is greater. Replacement products and parts may be new or remanufactured.

### Additional Warranty Terms & Conditions:

Repair or replacement or correction to product is limited to the electrical and plumbing contained in this product; including correction in installation and repairs along with failures associated to this product when performing during power failures or interrupted and or faulty electrical connections.
